"What?"

"What do you mean?"

I ride a motorcycle and I want the freedom to enjoy it. I am tired of having to argue the (lack of) safety features of a helmet. I am tired of justifying my existence.

Suppose I just give in? Suppose I was to concede, for argument's sake, that helmets did provide some form of "safety" and "protection" in their usage. I STILL DON'T CARE!

Skiers have been injured on the slopes. The speeds that they are able to generate are comparable to those of a motorcyclist but with less control. That is why they hit trees and die. They are not required to wear helmets. Equestrians ride. When they sit on a horse they are typically much further from the ground than motorcyclists. When they fall off or are thrown, they can hit their head and die. Yet they are not required to wear helmets. Bicycles can also reach the same speeds as motorcyclist's under regular speed conditions and adults are not required to wear helmets.

I suspect that the number of skiers, snowboards, equestrians, and bicyclists exceed the number of motorcyclists and, therefore, by numbers alone, suffer greater head injuries then do we. Yet no legislation has been passed requiring them to wear helmets.

So as to all of the safety arguments that do not seem to apply to any other activity then motorcycling, even if all of your arguments and concerns were valid, I STILL DON'T CARE. All I want is the freedom to ride my motorcycle on an even par with those other activities.

So here is the real problem. I DO CARE! I care about my rights as a motorcyclist. I care about my freedom to enjoy the activity. I care about being allowed to be treated as an adult and the respect that should be rendered as such. Thus I am a member of ABATE I will continue to dedicate my time, my efforts and, yes my money in the form of dues and attendance at social events.







Our trip took 13 days with only one minor mechanical glitch, my Dad's tail light. We tried to average between 500-550 miles a day, and stopping at


countless hotels. When we got back to the East Coast we stayed with our relatives that are in Ohio and New York. While in Canada, we also stayed with friends and family.






Special thanks to the hundreds of people that came out for this event. We will be here next year and hope to see all of you back again.





1999 LEGISLATIVE WRAP-UP KATHLEEN LOERICH

Bill Filed

The 413th Session of the Maryland General Assembly started on January 13, 1999 and adjourned April 12, 1999.

During the legislative session ABATE of Maryland introduced Senate Bill 239 with Senator Hafer as the primary sponsor. The bill's intent was to modify the current all-rider helmet law in Maryland to apply only to minors. Cosponsors who signed on to the bill include Senators Astle, Colburn, Haines, Mooney, Munson, and Stoltzfus.

ABATE of Maryland members contacted Senators and Delegates via letter writing, phone calls, personal visits, e-mail, faxes, and contacts made during Monday Night Lobbying.

Committee Hearing Scheduled

SB239 was assigned to the Judicial Proceedings committee in the Senate. The committee hearing for SB239 was scheduled for February 23, 1999. At that hearing three ABATE of Maryland members testified in favor of the bill and a gaggle of 'safetycrats' testified to oppose the bill.

ABATE of Maryland concentrated on the overwhelming improvements in the motorcycle safety record in the last 10 years, both pre-helmet law and post-helmet law. ABATE's testimony emphasized the personal freedom issue at hand, how a number of other safety devices met with difficulties when imposed on the public with a 'one-size-fits-all' policy approach, and how the State's own Fiscal Note indicated that the financial impact of changing the law would be minimal or none.

ABATE of Maryland recommended the following:

- Continue the admirable job done by the Motor Vehicle Administration in providing training to both new riders and experienced riders via the Motorcycle Safety Program. The Motorcycle Safety Program started in 1985. Accident information provided early suggests that the safety program has been instrumental in reducing accidents and subsequent injuries and fatalities.
- Raise awareness of all members of the motoring public that they share the road with both large and small vehicles. Encourage them to understand the limitations of not only their own vehicle, but of the vehicles around them.
- Encourage educational programs that educate drivers and riders regarding alcohol awareness.
- Provide information about safety techniques and equipment that allow motorcyclists to make informed riding decisions and appropriate consumer decisions.
- Continue the downward trend in the number of accidents that occur.

Conclusions drawn in ABATE's testimony and presented to committee members were:

 Motorcycle helmets do not prevent accidents. Motorcycle accident rates have decreased dramatically and subsequently so

- have injuries and fatalities. If you don't have an accident you won't get hurt.
- Riding and driving on public roads is a privilege given to the people of Maryland by their government. Serving on the legislature is a privilege given to legislators by the people of Maryland. In the spirit of this reciprocal relationship and as your riding constituents we request that you recognize us as the defenders of our own rights and safety.
- We have taken your challenge to decrease accidents, injuries, and fatalities. We as motorcyclists in Maryland, nation-wide, and possibly worldwide have demonstrated with tangible and obvious results that we heard you. In Maryland the number of accidents declined from over 3000 in 1985 to less than 900 in 1996 in response to this message.

ABATE testimony was followed by those opposed to the bill. Those who opposed the bill included several government agencies such as Maryland Motor Vehicle Administration, Department of Health and Mental Hygiene, Howard County Police, Maryland State Police, Baltimore County Police, Montgomery County Police, State of Maryland Executive Department, Maryland Department of Transportation, Maryland State Department of Education, Baltimore Mayor's Office of State Relations, and of course NHTSA. One notable non-government organization who provided written testimony was Government Employees Insurance Company (GEICO).

Most of the opposing testimony was redundant and relied upon the argument that motorcyclists are a public burden. Those who notably stood out from the rest were GEICO and NHTSA.

The GEICO written testimony read like pages from the NHTSA script until the summarizing paragraph where GEICO's representative Janice Golec stated, "Some Rights Are Not Worth Having." This inflammatory remark raised the ire of folks all over the country. Many people from ABATE of Maryland contacted GEICO with letters and phone calls objecting to these remarks. Others went straight to the top. GEICO is a subsidiary of Berkshire Hathaway Inc. whose CEO is Warren Buffett. Several people including our own newsletter editor Toni Robinson and Mike Osborn from California contacted Warren Buffett's office directly to express their displeasure with GEICO's statement.

NHTSA stepped in to the fray by sending Dr. Elizabeth Baker to testify on their behalf. Her testimony was from the NHSTA script. But she couldn't resist an attempt at crystal ball prediction at the end. She predicted that if SB239 were enacted, the number of motorcycle fatalities would increase 20 percent. Dr. Baker provided the most controversy that lasted into the summer months.

Those who lobbied for and testified for the bill were nearly always individual constituents representing his or her individual interests and desires. However, those who opposed the bill represented large well-funded organizations and government entities. What we have here appears to be government by the government and not government by

the people.

Favorable Committee Report 7 Yeas and 3 Nays

An emergency meeting was held at the ABATE of Maryland office on Sunday, March 7, 1999. During this meeting we prepared an emergency mailing informing members of the committee vote and to engage in full force lobbying of Senators to assure a successful vote in the Senate. When normal procedures are followed there are three readings of a bill. A reading is when a bill's title and purpose are read aloud on the Senate floor. SB239 would get its second reading on March 9, 1999. Ordinarily, this would simply be a procedural step that takes seconds to occur. The third and final reading is usually when a bill is debated on the floor and voted. The debate and vote for SB239 occurred during the second reading on Tuesday, March 9, 1999 instead of during a subsequent third reading. This all but negated the effect of our emergency mailing. By the time the mailing reached most hands, the vote was done.

Senate Vote

In spite of the heavy-handed opposition to the bill and the surprise turn of events with the vote schedule, SB239 missed passing the Senate by four votes.

Unfavorable Senate Vote 20 Yeas and 27

Four more votes making the vote 24 to 23 will achieve success for our helmet bill. This may be a 'year-in-review' article. But I can't resist asking everyone to start working on those 27 Nays now to see how many can be changed to Yeas.

NHTSA Investigation

NHTSA testimony didn't start and end on February 23, 1999. It took on a life of its own for the next several months.

On March 23, 1999 I attended an Introduction to Washington seminar hosted by AMA. Participants were assisted with the process of contacting US Senators and Representatives directly by going to their offices. A contingent from Maryland contacted every Senator and Representative for Maryland. Each one was asked to apply pressure on NHTSA to prevent them from lobbying state legislators and attempting to persuade local legislators to favor or oppose a particular piece of legislation. In fact, According to the latest version of the Federal Transportation Equity Act for the 21st Century (TEA-21), NHTSA is prohibited from lobbying in state and local legislatures. TEA-21 states:

"...prohibits the use of funds appropriated to NHTSA for the purpose of urging a State or local legislator to

favor or oppose the adoption of any specific legislative proposal..."

At least three times during her testimony Dr. Baker urged legislators to oppose SB 239. US Representative Roscoe Bartlett who represents the 6th Congressional District decided to ask the Inspector General of the Department of Transportation to initiate an investigation of NHTSA's actions. The US Department of Transportation investigation was initiated on April 14, 1999.

On June 11, 1999 the Department of Transportation responded to Representative Bartlett's request. They concluded that NHTSA complied with 'both the letter and the spirit of the law as intended by Congress'. Obviously, I am unhappy with their conclusion. In a ten page letter the Inspector General described why he believed this was so. There is a Section A in the NHTSA lobbying provision that states that NHTSA representatives may not lobby state legislators. There is a Section B that states NHTSA may testify if they are invited. The Inspector General relied solely on the invitation clause and indicated that Dr. Baker had been invited to testify. The Inspector General discarded any consideration of Section A because of the invitation.

On July 25, 1999 I contacted the Inspector General directly and requested copies of all documents, tapes, and minutes pertaining to the investigation. I also requested a copy of the letter of invitation. To-date, I have not received any of this information or a response. So, it still isn't over.

MRF and AMA Working With Representative Bartlett

Because of the door to Representative Bartlett's office being opened by ABATE of Maryland members, MRF and AMA were able to contact Bartlett about attempting an amendment to the DOT appropriations bill that would strengthen the NHTSA lobbying provision and prevent NHTSA from lobbying and testifying in Maryland and other states in the future. The amendment approach did not work so now MRF and AMA are working on other approaches for next year.

Summary

Sometimes I wonder about 'life-the-universe-and-everything'. This entire article is the result of trying to change one word in one law in the State of Maryland. The change proposed by SB239 would change the word INDI-VIDUAL to MINOR. Thus, making the helmet law apply only to those under 18 and not to adults. I have said many times before and I will say it again. Changing the helmet law is crucial, but it's a small part of the legislative and regulatory environment that we are forced to deal with. This one word change is evidence that this is true. The helmet law is the focal point, but assuring that large, uncaring, unwieldy government and private agencies do not slight motorcyclists is essential.

2000 MARYLAND LEGISLATIVE SESSION KATHLEEN LOERICH

The 2000 Session of the Maryland's General Assembly is nearly upon us. The General Assembly Convenes on Wednesday, January 12, 2000 at noon.

ABATE of Maryland will begin Monday Night Lobbying the first Monday of the session which is January 17, 2000. Visit the ABATE of Maryland office on 8 West Street in Annapolis anytime after 5:30 pm

and sign in. Then proceed to the legislative offices of your Delegates and Senators.

The legislative agenda for the upcoming session includes two key components. They are to introduce legislation that will place a cap on Motorcycle Safety Program course fees to prevent unreasonable increases in course fees and to introduce legislation that will eliminate mandatory use of motorcycle helmets by adult riders.

Legislation to cap Motorcycle Safety Program course fees came about as a result of the Motor Vehicle Administration arbitrarily increasing course fees for the beginner's safety course from \$50 to \$100 for in-state riders and from \$100 to \$150 for out-ofstate riders. This increase doubles the amount that an in-state student must pay to take the course. Such a drastic increase in fees could discourage many prospective students from taking motorcycle safety courses.

Legislation to amend the all-rider helmet law to eliminate mandatory helmet use by adult riders will be filed in the House of Delegates. It will be assigned to the Commerce and Government Matters (CGM) Committee. Contact members of the committee now and ask them if they support voluntary helmet use by adult riders.
