As bikers, motorcycle enthusiasts, whatever you wish to be called, we need to unite as a group. Yes, there are people fighting the good fight, but there needs to be MORE. Not only do we need to continue fight for the FREEDOM TO CHOOSE regarding helmet usage, but we need to fight for our rights in general. Motorcycling as we know it could look vastly different if we do not take immediate action. Mandatory trips to the dealer / manufacturer authorized repair facility may be the norm instead of your fixing it yourself or taking your bike an independent shop. New motorcycles may soon only be sold with electric motors. Fuel for your older bike may become difficult or more expensive to purchase. Drivers of vehicles my be entirely replaced by technology instead of human interaction. You may have to pay an additional fee based upon the number of miles you have operated a vehicle on a roadway. Sound "cameras" may decide that your motorcycle is too loud.

Does this concern you, because it should. These ideas are being talked about EVE-RYWHERE. Some of these topics have already been kicked around in Maryland and ABATE has been able to assist in defeating many of them so far. But you will hear this again, and again. NUMBERS MATTER. If politicians see a lot of people rallying to either support or defeat a piece of legislation, they take note.

We need to strengthen our numbers. Re-activate old / former members, recruit new members, and urge them all to be a part of the process. Go to a chapter meeting, help with an event, ask your friends, family and neighbors to join, and become an active participant in protecting your FREEDOM.

State Director's Corner

Ken Eaton, Executive Director

I want to take a few minutes to preach to the choir. We have received enormous amounts of calls, emails, social media messages, etc., about a rumor that the helmet bill passed in Maryland this year. This was just a misinformed rumor. The helmet bill **DID NOT PASS.** The Maryland General Assembly only meets for 90 days each year (early January thru early April). Every bill that gets passed must cross numerous hurdles in those 90 days and it really takes a village to get it done. If a bill does not get over all of those hurdles by April, it will never make it to the Governors desk for signature. Each year the process starts over, from the beginning. Those 90 days are extremely important.

You must still wear a helmet on the roadways in Maryland while riding a motorcycle. However, It really does seem that many bikers in Maryland would like to have the **FREE-DOM TO CHOOSE** when it comes to helmet use.

BUT, this law may never get passed unless these same people that would like to enjoy that **FREEDOM**, become active in trying to get that legislation passed. ABATE is always in Annapolis during session, putting in the work. However, we really need the legislators to see that this is a bill that a lot of people care about. Although we have a lot of friends in Annapolis, numbers matter. Monday Night Lobbying & committee hearings are where we really need people to show up and let the politicians know that this is an issue that we feel very strongly about. There are 65% of the states in this country that allow riders the **FREEDOM TO CHOOSE**. It is about time that Maryland gets added back to that list. Yes, BACK to the list. In 1992, the Maryland General Assembly took the right to choose away from bikers in Maryland. Prior to that, many of us remember that we could decide for ourselves when it came to wearing a helmet.

It is time for us to stand together with a large and loud voice as bikers in Maryland and tell them we want our right to decide for ourselves back! How can you as an individual help? It really is easy, but does require some effort on your part, and the cost for doing nothing is your **FREEDOM**. Attend a chapter meeting near you or visit a neighboring area. Attending and helping with events, listen to the legislative updates in your chapter or follow them on our website or on our FB pages. Arrange a time that you and others from your area and actually go to Annapolis, be seen and make your voice heard. You do not need to go every week, but 2 to 3 times per session would be fantastic! If we could get members from all over the state to make that commitment, we could make a difference! In addition, telephone calls, emails, letters, committee testimony, etc. are all equally important.

It starts locally. Get to know your senators and delegates. They may not always agree with your viewpoint, but they should always take the time to listen to you as a constituent. You need to be able to recognize them on the street, and they need to be able to recognize you. Go to county fairs, Chamber of Commerce events, fundraisers, community events. They are usually there, talking to everyone, because numbers matter. The more people they get to know and meet, the more votes they could possibly count on for the next election. So, **BE ABATE**. Wear your ABATE gear. Spread the word, shake some hands, be seen and **MAKE YOUR VOICE HEARD!**

I would like to take this time to thank all who attended and especially all who worked to make ABATE of Maryland's 50th Anniversary a successful and enjoyable celebration. A half-century of advocacy for all motorcyclists in our state is certainly something to be proud of. Nothing in life is guaranteed but I find it difficult to envision a 60th Anniversary. I assured them that our efforts once again came up short, explaining to them that we had the votes in committee but could not get the chairman to hold a vote on the legislation. I have fielded at least a half-dozen more calls of a similar nature in the last 5 days. Several of these people expressed skepticism at the answers I gave them. I have had the same response when I tell them that the state of Maryland has already set in motion a plan to outlaw internal combustion engines by 2030. I can't help but think that if everyone who is hoping to benefit from our labors, would have participated in the process we might be looking at a different scenario today. I tell all of you this not to discourage you, but to let you know what we are up against. I firmly resolve to remain involved in the struggle to promote and preserve our way of life as long as I am a resident of the Old Line State. I hope you will resolve to do the same. Continue to RIDE SAFE.



NCOM is more than just a single organization; it is comprised of numerous motorcycle rights groups, clubs, and associations, all working together for the greater good of the biker community. Today, the coalition has expanded to include hundreds of thousands of riders and more than 2,000 member organizations from all over the United States.

At its core, NCOM is an association built and run by bikers for bikers. Its National Council, designed to facilitate effective communications nationwide, is comprised of one member from each participating organization. Motorcycle rights leaders representing 11 regions make up its Board of Advisors. The group also contains a Legislative Task Force that includes state legislators, advocates, and a United States Senator.

Unlike with other organizations, groups can join NCOM at no cost, gaining access to its tools and resources. NCOM does not impose membership fees or ask its members for funding. Instead, 100% of the organization's monetary backing is provided by the Aid to Injured Motorcycles (A.I.M.) program and its associated network of motorcycle injury lawyers. Each A.I.M. attorney gives a significant percentage of their legal fees from motorcycle accident cases to NCOM, ensuring that the coalition can continue in its work.

No matter what type of bike you ride or what patch you wear, all motorcycle groups are encouraged to join the National Coalition of Motorcyclists.
