We are very fortunate to have this opportunity to do the raffle again. So get your tickets, while you still can. Because the bill regarded the State House it was heard in the **Economic and Environmental Matters** Committee. About now some of you might be getting steamed thinking "what does this have to do with motorcycle rights" "ABATE shouldn't be concerned with this issue". Let me guarantee to you, guns are not the issue. Personal freedoms, the right to be able to decide what is good for ourselves - as we are responsible adults, and the fact that the government which is supposed to listen to me and you because we are their consistuents, government that was founded by leaders such as Jefferson, Madison, and Lincoln. 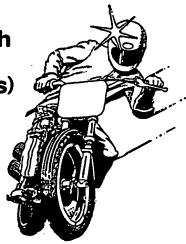

REPORT FROM THE MRF CONVENTION:

When the subject of the MRF Meeting of the Minds first came up, I thought that it would be nice to attend but I didn't really have any extra money to spend on going to a convention. Even with ABATE covering some of the expenses, I wasn't sure it would be worth my while to go. Now don't misunderstand me, you can always learn something no matter where you are. But, I just wasn't sure that the Meeting of the Minds was going to be a value added experience. Well let me tell you how wrong I was about this one. First of all, there was somewhere in excess of 400 of the best freedom fighters from over 38 states in attendance. If you have never been around a large group of dedicated bikers who have a single focus of protecting their rights, you have really missed something. These folks are the experts when it comes to grass roots lobbying. Trading experiences both good and bad with these folks can give you the chills. The single biggest reward of the week was getting to know the people who represent other motorcycle rights rights organizations throughout the country. The yuppies would call it networking. Well call it what you like, it is the best way to contact and develop a relationship with folks like us who are continually fighting to keep free. Since my return, I have had to contact several of my new friends and brothers from other states to ask questions about their states accidents data, lobbying strategies, public service videos, and most importantly just to jaw with them. If I had taken nothing else from Denver, the names and numbers of folks I met and came to know was more than worth the trip. In case you have haven't figured it out the Meeting of the Minds was in Denver. Nice town, great people, especially the Colorado ABATE folks who hosted the event. They deserve alot of credit for the work they put into organizing the convention. Maryland ought seriously consider hosting one of these things in 2-3 years from now.

I've rambled enough about the place and people.

Let me spend a little time telling you about the workshops that were held. Once again the top people available were brought in for these sessions. Workshops on organization, lobbying, media relations, generating media copy, statistical analysis, federal funding, police relations, legislative process, putting on events and many more were held over a two day period. Because of the time frames and number of of topics, all of the Maryland attendees split up so we could cover all of the workshops being offered. Each of us was rewarded with some insight that we are able to apply to our cause here at home. Pappy picked up some info about 402 funds. I got some good tips about dealing with the media. Tips like never answer a question without first repeating the question. Never invite press to an event and leave them unattended. Without an escort you never know what they might get into and twist around on you. If you make up flyers, print something on both sides to make use of the paper and discourage them from becoming someone elses scratch paper. A membership application or organizational promotion is always a good filler. I also learned tips on writing good news copy or press releases. Granted my style in this article is not very polished or formal, but that's because I tend to write conversationally to my friends. I was able to attend the workshop on statistics. The primary lesson from this session was to question the data sources and how the data are applied to the material being presented. Virtually all statistical data can be presented in a manner that will support opposing viewpoints. We should be very careful of using statistical data and examine all data used to support our opponents views with a very careful eye. I found the police relations workshop interesting but left feeling that the officer who conducted it would have done better to focus more on problems relating to helmet tickets. It was still a good work shop but the helmet area was weak primarily due to the fact that the officer was from a non-helmet

law state. I did however, get a good insight on how the various types of radar and VASCAR work. I hope that you're beginning to see that the Meeting of the Minds was a working experience. Now that doesn't mean that we didn't have any fun. Friday night we went to a fundraiser for Senator Ben "Night Horse" Campbell. This guy is our best friend and ally in Congress. He is the most straightforward outspoken and real person I have ever met in politics. It has to something with his heritage and being a motorcyclist. Now if we could only get a few hundred more like him. He spoke to us again on Saturday morning and told us that we must constantly be on guard to protect our freedoms. He suggested that the upcoming health care battles and some other "Clinton" initiatives could be tough on us and we need to keep our eyes open. The banquet on Saturday night was a ball. The awards ceremony was touching, funny, and for many richly deserved. I was very proud when ABATE of Maryland was singled out for the efforts all of us put forth to save the Motorcycle Safety Program. Yes, if you have any doubts, other states watch what we do with our legislature just as much as we watch them. I could not help but feel proud of ABATE of Maryland when a complete stranger came up to me and asked how we convinced Steny Hoyer to cosponsor H.R.

799.

I left BWI for Denver not knowing what to expect from the Meeting of the Minds. I really wasn't sure what I would get out of it. Now that I'm back, I'm sure that what I got there was well worth the time and expense. In fact some of it was priceless. I came back charged with a sense of purpose. You cannot help but get pumped by being with the folks who are the spearhead of the motorcycle rights organizations. The fact that I was surround by some of our best people just made the trip all the more enjoyable. I want to thank Lynn Oldenburg, Tom Greenbank, Gary Boward, Tom Bruce, Linda Wainer, Chuck Blankenship and Mike Sage for being gracious enough to help me share and learn from this entire experience. I would like to close by saying that every member of ABATE who believes in what we are doing should consider attending some type of conference such as this one. It does not have to be the MRF conference in St. Louis next year. It can be a regional meeting such as the Two Wheel Convention in New Jersey or the Pennsylvania meeting Mother' Day weekend. The point is that these events tend to motivate our people, train our people and unite our people. I'm trying to stash a little extra coin now because I hope to go to St. Louis

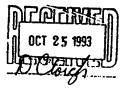

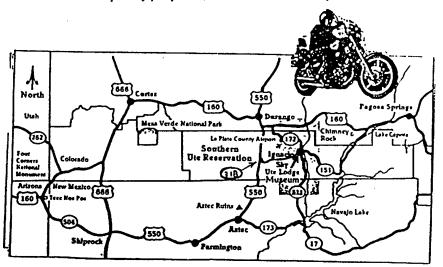

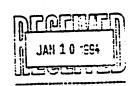

CAMPBELL INTRODUCES BILL TO DELAY PENALTIES ON STATES THAT DON'T MANDATE HELMET\SEATBELT LAWS, ADVOCATES EDUCATION

U. S. Sen. Ben Nighthorse Campbell today introduced legislation that delays for two years the penalizing of states that have not passed laws mandating helmet and seatbelt use, giving states the option of either passing helmet and seatbelt laws, or establishing motor safety programs, exempting those states that already have safety programs in place.

"Penalizing these states is not only a burdensome Federal mandate placed on the backs of state legislatures, but it is also an erosion of civil liberties and personal freedom," Campbell said. "These penalties are imposed regardless of whether the state has already allocated funds to helmet and seatbelt safety programs, and regardless of a state's individual safety record."

Campbell's bill will provide relief to 29 states - Colorado among them - that have been financially penalized under the Intermodal Surface Transportation Act of 1991 (ISTEA) for not having passed laws mandating helmet and seatbelt use by Oct. 1, 1993. These states face penalties in fiscal years 1995, 1996 and 1997, and ill be required to transfer transportation and construction dollars to safety programs outlined in ISTEA.

Initially, these 29 states are being forced to shift 1.5 percent of their federal highway dollars to safety programs. If a state has still not enacted seatbelt and

helmet laws by Sept. 30, 1994, it is required to shift three percent of its' federal highway funds into safety programs.

Campbell noted that Colorado does not have a mandatory helmet law and that a bill to implement one recently introduced in the state legislature failed to pass. Despite this, Colorado has a motorcycle fatality rate almost 30 percent below the average for states with mandatory helmet laws. Of the top 12 states with the best motorcycle safety records, only one has a helmet law.

"Evidence clearly indicates that the most effective way to reduce motorcycle accidents and motorcycle fatalities is through comprehensive education programs, as opposed to mandating helmet usage," Campbell said. "Currently, 42 states have established and funded some sort of safety program."

I realize the motivations behind ISTEA and those who wish to force states into passing helmet and seatbelt laws are doing so out of concern for the safety of the traveling public, but, clearly, mandating helmet usage will not address the real problem of rider inexperience and lack of training."

Legislative Update: Maryland General Assembly 1994

Delegates Owings and Astle who both ride motorcycles, sponsored a bill which would allow more than one motorcycle to park in a metered spot. They both testified before their committee as a pair. It went something like this: "Hi I'm Delegate Owings." "Hi I'm Delegate Astle." "I ride a motorcycle." "I ride a motorcycle, too." "And when we ride on our motorcycles all over the state we really enjoy it." "Except when we park our motorcycles side by side, because we can get ticketed." Several ABATE members testified that this would ease parking congestion, and further explained that if one bike parks first and then the rider returns later to find another bike in the spot as well and if they get ticketed they both get ticketed. Prince George's County and Howard County municipalities submitted to record that they would not lose any revenue if this bill were passed. Their was not opposition testimony at the hearing. Unfortunately, other municipalities lobbied against this bill behind the scene and it died in committee. Only three members of the committee voted for this bill: Delegates Astle, Owings, and Roesser. If this bill comes back next year, we will have to lobby just as strong as the municipalities, in order to get this into law.

The anti-discrimination bill was heard in the Senate Judicial Proceedings committee. The guys from the Baltimore Chapter, Lee Dix and Wil Crum, are responsible for getting this bill into being. Working with Senator Collins, they were able to get several co-sponsors. The testimony was excellent for our side of this issue. There was no opposition that testified. The bill was passed unanimously out of the committee and had a 2/3 majority in the full Senate. At Press-time a hearing is scheduled for the House Judiciary Committee and if we can get it out of committee we have an excellent chance to see this one come into law. If you want to

see a copy of this bill it is reprinted on the next page.

The helmet bill was heard in the Senate Judicial Proceedings committee. We had the votes before the bill was heard. Hundred of ABATE members had been to Monday Night lobbying and sat in the balcony of the Senate Chambers. We had quite a few Senators that said they would vote our way if it came out of committee. Unfortunately, the media swarmed into Annapolis the day of the hearing. Dr. Alcorta, temporary head of the EMS – has since the hearing stepped down, and his cronies jammed the media with their cooked statistics. I'm sure you must have heard, "In the year following the passage of the helmet law motorcycle fatalities have decreased 20%". Well the year in which he refers to is the calendar year. Remember when the helmet law went into effect. Sure you do, it was October 1, 1992. So any statistics have to be compiled from that date forward. Not January – December. The state police compile the fatality data from month to month, so it isn't as if it is difficult. It just proves the old saying, "Figures don't lie, but liars figure".

The media was in Annapolis in force because the Governor had called a press conference that afternoon to announce what Maryland was doing about the Asian Cholera outbreak effecting the waterfowl and fish eating birds in the Chesapeake. (Up to this point I don't think the man even knew about the bill.) Well, a reporter interrupted this press conference and asked his opinion about the repeal bill and Governor Schaeffer's face turned beet red. And he responded vowing to veto this bill if it got to his desk. And then the political machine started turning it's wheels and that ladies and gentlemen is that. You can

read about some of the legislative efforts to regain our freedoms by reading the newspaper article reprinted in this issue.

We put on a good campaign. And the motorcyclists in Maryland can be proud of their relationships with the legislature. We could use several hundred more motorcyclists to come to Annapolis. Next year, with the legislature changing. We need more people from Baltimore, Montgomery, and Prince George's county on a regular basis because that is where the majority of legislators are from. Representation is based on population. We will also see more diversity in the legislature next year. So if you are a woman or a minority, come to Annapolis - your legislatures need to see you as motorcyclists. Thank you to everyone for this great legislative effort we had this year. Keep up the good work, we will have the freedom to choose again. Look in your upcoming ABATE Newsletters for a voting guide, we'll let you know who supports our efforts. Motorcyclists seek repeal of measure

Two years after losing the free-dom to ride bareheaded, motorcy-clists returned to Annapolis yesterday to renew a battle over helmets that has stretched, on and off, over

the last 20 years.

Members of Maryland's largest motorcycle group asked state senators to repeal the law requiring motorcyclists to wear helmets. Although they found several sympathetic ears on the Judicial Proceedings Committee, they face an immovable opponent in the Governor's Mansion.

Gov. William Donald Schaefer yesterday vowed to quash the repeal if it manages to pass the General Assembly and land on his desk.

"I promise you I will veto the bill. Absolutely!" the governor said. "We're trying to save people's heads

from being smashed in."

A governor's veto in the last year of a four-year term — such as this year - cannot be overridden by the next legislature. Supporters of Maryland's helmet law, however, hope to put an end to the repeal movement before it gets that far.

They say they have statistics and 11 lives - on their side.

There are 11 people alive today in the state who wouldn't be here if we had not passed the [helmet law] two years ago," testified Sen. Arthur Dorman, a Democrat from Prince George's County.

The number of highway deaths among motorcyclists dropped by 11 since the state helmet law took effect, from 54 fatalities to 43.

In addition, the number of motorcyclists admitted to the Maryland Shock Trauma Center with serious head injuries decreased by 17 percent, according to testimony by Dr. Richard Alcorta of the Maryland Institute for Emergency Medical Services Systems.

The less severe the injury, the less society ends up paying in medical costs for uninsured or under-insured people, helmet law supporters

The Maryland motorcycle group, A Brotherhood Against Totalitarian Enactments or ABATE, is skeptical of those statistics.

Chuck Blankenship, who has been riding for 28 years, said helmets actually contribute to neck and spine injuries, even if they protect wearers from head injuries. Dr. Alcorta later disputed that claim.

But Mr. Blankenship had another important weapon in his fight for re-

Eastern Shore secession bill dies

ANNAPOLIS (AP) - Accompanied by shouts of "Let them go, let them go," Sen. Walter Baker attempted Tuesday to take the Eastern Shore out of the union - or at least out of Maryland.

Mr. Baker, the sometimes crusty conservative from Cecil County, said he and Eastern Shore voters were weary of what he described as wrongheaded decisions by the 1994 General Assembly and it was time to consider secession.

The Democrat asked the Senate for permission to introduce a bill that would let Eastern Shore voters decide this fall whether to secede from the state, the United States or

But because the 1994 session is nearing its April 11 adjournment, the introduction of new bills requires a two-thirds vote, and Mr. Baker's proposal fell short, 27-15

Mr. Baker later said he wasn't sure whether he preferred that the Eastern Shore become the 51st state or an independent nation. But he said there was no doubt that given the chance, voters on the Eastern Shore would choose overwhelmingly to

secede.

Mr. Baker, who has a reputation for dry wit, said if the Eastern Shore secedes "we're going to call it the state of Maryland.

"The rest of the state can call itself

whatever it wants."

Mr. Baker said he introduced the bill primarily to make clear to the rest of the state that the Eastern Shore is displeased with much of what the legislature has done this

FREE WHEELING

By now the public is well acquainted with motorcyclists' resistance to mandatory helmet laws. But if legislation is any measure of the national sentiment, riders' "freedom of choice" has been steadily losing out to safety arguments and concerns about disabled riders on the medical dole.

But the public remains unaware that the helmet issue may not be as simple as that argument makes it appear.

At the same time the federal government has been using highway funds in a carrot-and-stick approach to foster state helmet laws, it has done nothing of note to advance the state of head protection. Most experts consider Department of Transportation or Snell standards for legal motorcycle headgear eccentric and as dated as the so-called "Hurt report" on motorcycle accidents.

As a result, critics of the helmet initiatives are not limited to "Easy Rider" types who have long said that helmets impair a rider's vision and hearing. Rather it is being argued that the kind of helmets the government has us wearing may imperil our health.

Dr. Rodney Cooter, an Australian expert on cranial and facial injuries, has offered evidence that today's full face helmets transmit a fatal blow to the base of the brain in many kinds of accidents. Cooter advocates a redesign of helmets to provide a chin piece able to "give" in an accident, much as the human jaw does to protect the brain.

While the merit of Cooter's arguments remain controversial, there is no disputing the fact that established helmet design has not kept pace with the

safety gains in motorcycles themselves -such as antilock brakes introduced by BMW motorcycles five years ago.

Worse still, in addition to not having the best helmet design for tomorrow, we may not even have the best of today. Of the four top-rated helmets cited in an exhaustive Motorrad magazine test, none are sold in the United States.

Two of them, a Marushin and a BMW Systems model, were withdrawn from the U.S. market because of product liability concerns. For the same reason, Schubert, a top-rated helmet manufacturer, flatly refuses to even consider U.S. import of its models.

Accordingly, even those motorcyclists who wear helmets by choice may not be getting the kind of comfort and protection afforded the overseas rider. In short, American motorcyclists are required to wear helmets but at the same time are denied access to the best available technology.

Improved helmet safety and comfort are surely possible, but the focus seems instead to getting the riders to wear something on their heads. In Daytona this last year, many riders could be seen wearing "tin pot" helmets with either no or bogus DOT certification.

A crackdown on these helmets has begun in some jurisdictions, but this has not resolved the issue of top helmet availability. It is an old maxim in motorsports that "racing improves the breed." This is especially true in motorcycling, where the nimble chassis and powerful brakes of yesterday's race bike are now affordable and in the showroom.

And it is hard to quarrel with the results. The best-selling Honda CBR900RR exploits many of the racing breakthroughs of recent years to produce

a streetbike of extraordinary performance capability. With its lightweight and tractable power, the 900 cc machine is fully the equal of exotic superbikes of just a few years ago. In lighter displacement, much the same can be said of the Kawasaki ZX7 or Honda's CB600F2.

Where possible, innovations that have proven themselves on the race track find their way into street bikes, making the average rider's bike not only potentially faster but potentially safer as well.

In an even more direct sense, the small Italian marque Ducati has profited from its race program. In Word Grand Prix as well as Superbike racing Ducati twins made a name for themselves by competing and winning against the Japanese Big Four.

The cache of Doug Polen's victories has translated into hot sales of street models such as the 750 and 900 SS sportbikes. Conversely, it is worth noting that non-racing Italian rival Moto Guzzi is not doing as well despite the long-awaited introduction of its 4-valve Daytona sports model. Racing gave Ducati visibility.

Why then doesn't everyone race? First, it costs lots of money. Second, as superexotic Bimota can attest, there is no guarantee of success. Finally, there is the rueful testimony of participants of recent racers in the recently aborted Mexican Superbike race.

After hauling their entire GP teams across the Atlantic, Ducati's Carl Fogerty was incensed when he was forced to scratch his attempt to unseat series leader Scott Russell of Kawasaki. The reason: dogs, soccer balls and pickup trucks on the track during 150 mph practice sessions. Racing may improve the breed, but it does nothing for the disposition.

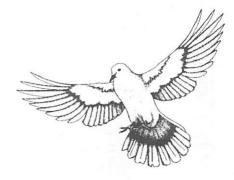
This Christmas season the members of the lower Eastern Shore chapters of Abate of Maryland decided to help a family have a better Christmas than they might have been able to afford.

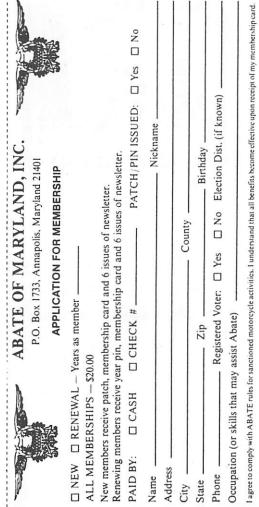
