Legislative Update

Federal

If you missed the ABATE Staff Meeting in January at the International Show, you missed listening to U.S. Senator Ben Nighthorse Campbell updating our members on the federal Legislation. There are several federal bills that will benefit motorcyclists throughout the nation. Currently, Representative Young from Alaska has introduced a bill that would repeal the helmet penalty provision of Section 153 penalties. (See letter from MRF on page nineteen.) Senator Snowe will introduce a companion bill in the Senate. Senator Campbell will introduce a bill that would except States with rider education from the penalties. We need to write our Federal Legislators for their support of these bills. There is a momentum in Congress to "get the government off our backs" and also "unfunded mandates" are a hot subject as well. Don't forget to mention to your Federal Legislator that these penalties violate the 10th Amendment to the Constitution (States Rights). See the list below of who to write to:

By the time you get this, I don't know where things will be in the Legislature, but I can tell you this: get down to the ABATE office any and every Monday night in March. We have two bills to lobby for: SB 322 and SB 191. Call legislative services. From the Baltimore area 410-841-3810, and from the Washington area 301-858-3810. From other areas: 1-800-492-7122. Get copies of all motorcycle legislation sent to your mailbox. Write the Senators and particularly the Delegates from your county. And also write the Delegates on the Commerce and Government Matters Committee and the Judiciary Committee. (See lists on page nine.) These committees will hear one or the other bills. SB 322 will repeal the helmet law for over 18 riders and SB 191 is the anti-discrimination bill. (See copy). If you are not comfortable writing a letter, call to make an appointment with your legislator on a Monday night and come to Annapolis to lobby; you won't be alone. We get hundreds of people to come to the Rally in October to ride into Annapolis with or without your helmet. Now it is time to come when it really countsduring the legislative session. The first Monday night we had 50 people. We need to double that number now. Come to Annapolis. You can call the toll-free number for ABATE for all the latest legislative news: 800-843-0252. We work hard all year to raise money for

our legislative efforts. It's time for you to come and join us—our voices will be heard.

ABATE has a lot of friends in the Senate and the House, but it may be your Senator or Delegate that we have not been able to see. These legislators like to see people from their communities and counties. Come see your legislator.

If you still can't get down to Annapolis or write, call and speak to their legislative assistants. Let them know you want them to vote for SB 191 and SB 322. Send them a telegram by calling 1-800-325-6000. We need the legislators to get our message: No more discrimination—freedom from helmets (if we choose).

I remember a time when I'd say yes to a ride anytime, anywhere, and for as long a run as you want. I still find myself saying, "Yeah, sure, cool!" But, as the years go by I'm starting to envy the people I see in their nice toasty warm cars (secretly, of course), listening to some good tunes on their radios. Fortunately that type of weather hasn't hit yet—so "Hey, Rusty, wanna go for a ride?

This article is all about dressing for your ride in different temperatures. Although this time of year the daytime temps aren't too bad, take into consideration how cool it is in the morning and again in the evening, after the sun sets. Besides the actual temperature outside, let's keep in mind the humidity and also the length of time you'll be on your bike. For the sake of this article, let's say 'standard dress' is jeans, t-shirt, and boots-alright? If you wear too many clothes for the conditions outside it can be just as bad as not wearing enough. Wearing too much causes a "sweat to ice" situation. That's when you're too hot and you start sweating inside your clothes—then the wind hits and-BURRRR! You get ice! This can also happen when you put all your clothes on too soon before actually leaving-so make sure, if your ol' man or ol' lady is long on words when saying good-bye, that you wait until you are actually out the door and headed for the bike before you start to layer.

60 deg.—Nice enough day. The sun is shinin' bright and it feels warm. Now

add the wind chill factor, when you're on your bike and moving, the temperature can drop 20-30 degrees. So—standard dress along with your leather and gloves should be good. For people like me though, a bandanna around your face helps keep cold and running noses warm.

50 deg.—Add a set of thermals to the above.

40 deg.—All of the above plus a wool sweater. (Wool really seems to retain heat the best, even if it gets wet). You'd probably also feel warmer if you add a pair of chaps and a leather vest under your jacket, and a bandanna should be needed by all.

30 deg.—Add extra socks and heavily lined gloves, and you might even want to try a ski mask instead of the bandanna, but uh... try and remember if you need to stop off at say, the bank—take the mask off before entering the building. Or you might get approached by a uniformed, gun carrying, I.J. who says something really stupid like, "Make my day!"

20 deg.—Why not try some of that electric stuff on the market. Nowadays there are electric gloves, vests, chaps, socks, everything you could possibly want for all those 2,000 favorite body parts. Hell, you could be the new "Electric Bikeperson" (just trying to be politically correct). Just be careful of short circuitng or a power surge (oooh, could be fun!).

UNDER 20 deg.—ARE YOU NUTS? STAY HOME! Ain't nothing gonna keep you warm—think truck or car! But for those of you who are nuts, like my ol' man or Chris from Washington County, watch out for signs of hypothermia (subnormal body temperature). It starts with shivering that you can't control and your teeth chattering. Then your fingers and toes start to hurt like hell—that's when

they're going to freeze. If they happen to stop hurting, you're in big trouble—prepare to stop cause you'll get to feeling sleepy and lightheaded, after that you fall asleep and die, sooo... at the first sign of hypothermia—PULL OVER! Find a restaraunt, a bar, build a fire, whatever, Breathe through your nose, because those little hairs warm the air you inhale before it reaches your lungs. Breathing through your mouth causes too much cold air inside you and chills you from the inside out. Try to stay as calm as possible. I know it's hard, the urge is real great to shake rattle and roll inside your boots, but your blood flows a lot better when you're relaxed and that warms you up a lot faster. And finally, no matter how good it sounds-all your hot drinks and alcohol don't warm your body-they actually lower your body's temperature making you colder. So, you'd be better off waitin' till you get wherever it is you're going for the night.

Aid to Injured Motorcyclists Attorneys Win \$12 Million Settlement for Defective Helmet

January 27, 1995, Encino, California - Aid to Injured Motorcyclists (A.I.M.) attorneys Jim Stuczynski and John Bonanti of the law firm Bernard Stuczynski & Bonanti of Erie, Pennsylvania, announced today that K-Mart Corporation has agreed to a structured out of court settlement worth \$12 million in the case of an 11-year-old motorcycle passenger who received a broken neck and severe head injuries while wearing a defective helmet sold by the giant retail chain.

On May 27, 1988, young Edward Waddell and his father were enjoying a Sunday ride through Geistown, Pennsylvania, to have lunch with his mom at work. Without warning, a drunk driver (.21 BAC) lost control of her car in a turn and crossed over the center line into the path of the oncoming motorcycle. Upon impact, Edward's Land Tool Company RG-9 helmet rotated forward, exposing the back of the boy's head to severe trauma.

Edward suffered a fracture of the C2-C3 vertebrae and a closed head injury which has left him quadriplegic and blind. Now 17, he looks forward to a life of respirator dependency because of a helmet that shouldn't have been on the market in the first place.

A.I.M. attorneys Jim Stuczynski and John Bonanti filed a product liability claim against K-Mart for distributing a defective helmet. Land Tool Company had been the main supplier of one-size-fits-all helmets to K-Mart, but had been sued out of business because of faulty design and manufacturing. Through depositions of Land and K-Mart employees, Bonanti showed that the department store chain was reckless in the selection of Land Tool as a manufacturer and continued to market Land Tool helmets to the public.

"The concept of product liability is to protect consumers from dangerous products," said A.I.M. founder, attorney Richard M. Lester, "and motorcyclists deserve as much consumer protection as any other segment of society, especially when their lives depend on it."

K-Mart settled the case before trial for \$4 million, structured over 36 years for a total of more than \$12 million. A lawsuit, including punitive damages, is currently pending against the drunk driver's insurance company for allegedly acting in bad faith by refusing to settle for the \$50,000 policy limits.

ACLU to File Class Action Lawsuit on Behalf of South Carolina Motorcyclists

January 30, 1995, Spartanburg, S.C. - The American Civil Liberties Union (ACLU), with assistance from ABATE of South Carolina and Aid to Injured Motorcyclists (A.I.M.), is planning to file a class action lawsuit in response to the violation of Constitutional rights of motorcyclists participating in a Red Cross charity run held in Spartanburg, S.C., on September 11, 1995.

ACLU attorney Gaston Fairey met with plaintiff bikers and A.I.M. representatives on December 8th to discuss plans for the lawsuit. The suit will seek an injunction against future actions by law enforcement personnel. a declatory judgement that such conduct is illegal, and punitive and real damages. It will be filed under Section 42 of the U.S. Code 1983 of the Civil Rights Act and will claim violations of the 1st Amendment rights of freedom of association and assembly, as well as 4th Amendment protection against unreasonable search and seizures.

The suit stems from an incident at the Piedmont Interstate Fairgrounds in

Spartanburg, S.C., where over 550 motorcyclists were participating in a poker run to raise money for the American Red Cross. The fairgrounds was the final stop on the run and riders were to be treated to a concert featuring the Marshall Tucker Band. Instead, they were greeted at the gate by nearly 200 law enforcement offices including FBI, BATF, SLED, SWAT, SCAT, National Guard MPs, Highway Patrol, K-9 patrol dogs, Spartanburg County Sheriffs, Spartanburg Department of Public Safety, and other unidentified personnel in full military regalia.

The riders were stopped and forced to display their driver's license and were videotaped as the officer read aloud their license information. Individuals fitting certain "profiles" were taken aside for further questioning and photographs of their clothing, tattoos, or other identifying marks. All information collected was reportedly going into a national database on biker gang activities. Many of the participants were forced to submit to searches of their saddlebags, purses, and belt pouches.

Only two riders were arrested as a result of these over zealous tactics; both for possession of firearms, but the charges have since been dropped and their guns returned. They have not joined the class action.

A.I.M. attorneys E. John Dawgs of South Carolina and Jerry Abendroth of Georgia have been assigned to assist the ACLU on a pro bono (free) basis, but the ACLU still estimates that direct legal expenses could exceed \$20,000. ABATE of South Carolina has established a Legal Defense Fund to help defray those costs. Disabled Bikers Win Victories

Disabled motorcyclists in Pennsylvania and Florida were successful in convincing their state legislatures to approve the use of a handicapped decal for motorcycles. In Harrisburg, PA, paraplegic rider Robert Evans, with help from ABATE of Pennsylvania and the Pennsylvania Motorcycle Dealers Association, also won the right to take and pass the state's motorcycle driver's exam with his modified sidecar rig. In Tallahassee, FL, the Reverend Robert "Kaiser" Hershberger lobbied for the law which now allows disabled bikers the same rights as other disabled motorists. The one-legged minister is no stranger to politics, as he lobbied for the passage of a similar law in Massachusetts before moving to

Florida. "This is not a luxury, this is a necessity," said Rev. Hershberger, adding that 5 percent of the nation's motorcyclists are disabled.

European Parliament Actions

In a move which could effectively ban 2-stroke engines and possibly affect production of air-cooled motorcycles, the Economic & Monetary Affairs Committee of the European Parliament accepted proposals from the European Commission to limit motorcycle noise and emissions. Fortunately for motorcyclists, the commission rejected a proposal to limit horsepower to 100bhp, as well as an anti-tampering measure which would prohibit modifications and home repairs. The proposal is expected to be voted on in

the next full session of Parliament later this month.

U.S. Savings Bond Ad Slams Bikers

Uncle Sam has launched an advertising campaign for U.S. Savings Bonds that features a leather-clad young woman astride a Harley-Davidson motorcycle with the statement, "Your bonds just might mature before you do." The insinuation that bikers are immature seems inappropriate when you consider that demographics show the typical motorcycle owner has a higher than average education and income level. Not meaning to sound unpatriotic, but you'd probably get a better return on your investment with the Harley anyway.

New Book Covers Many Facets of Motorcycle Safety

"HELLP TAKE A BITE OUT OF FEDERAL MANDATES" REPEAL PENALTIES ON STATES WITHOUT MANDATORY HELMET LAWS

Dear Colleague:

During the week of February 6, 1995, I intend to introduce bill repealing the penalty against states that have not enacted mandatery motorcycle helmet laws. Many of you cosponsored similar legislation last year, though my bill is slightly more narrow in scope -- It will not address seat belt laws. I am looking for your support and ask that you be an original cosponsor.

The premise for this bill is simple: the federal government should not force states to enact laws reserved by the Constitution to the states. However, the federal government was given the means to pressure states to enact helmet laws through a penalty created in the Intermodal Surface Transportation Efficiency Act of 1991 (pt. 102-240). Fully half of the states do not have the helmet laws and have stood up to this mandate. Thus, they are already feeling the bite of the penalty -- a 1.5% reduction of FY 1995 state highway construction funding, and now 18 hereafter.

States refusing to enact helmet laws have legitimate reasons for doing so, not the least of which is that their citizens oppose such laws.

Under this bill, any state may choose to implement helmet laws, and any may elect not to, free of federal coercion or penalties. I hope you can join me in sponsoring this measure. Please contact me or Chris Fluhr of my staff at x5-5765 if you wish to be an original cosponsor or have any questions.






